

**Concealed Firearm Permit Fees**

**Preface**

In addition to the purchase of a firearm, and with the exception of the CCW Course Fee, the following "Fees" are the charges in obtaining a Concealed Firearm Permit regardless of where/whom by the CCW Course is offered. The following "Fee" schedule reflects all the associated costs for each State, and combination of State permits applied for.

**Introduction**

Each State mandates a minimum standard of training for one to apply for, and obtain, a Concealed Firearm Permit from that State. The minimum standards will vary from State to State, but should be met by each CCW Course offered when being "signed off", regardless of where/whom by the CCW Course if being conducted.

All associated costs should be considered when applying for a CCW Permit. Most people consider convenience when selecting a place to attend a Concealed Firearm Permit Course. Considering the following permits are valid for 5-7 years, and the purpose in possessing a concealed firearm, on your person at all times possible, is for self-defense and the defense of others, convenience may not be one of the top priorities in selecting a Concealed Firearm Permit Course. Ultimately it is the responsibility of each person, who holds a CCW Permit and carries a firearm, to know and uphold to the moral and legal obligations assumed once that decision is made. Be certain that the course you choose will emphasize this, and provide you the tools to "come home"...from any situation, physical or legal.

Additionally, consider the value of the training you will receive. Each establishment and/or person conducting Concealed Firearm Permit courses will have their own approach and emphasis. The emphasis is typically based on their personal experience which may be the motivation in the presentation of the class. This is not to imply a bad thing, but rather to maintain objectivity when attending any CCW Permit Course.
